## Interested in joining the board of the CBA?

Frequently Asked Questions:

If I am elected what will I need to do?

1. Participate in Board meetings. Meetings usually take 2 hours or so.

2. In normal times, the Board meets face-to-face twice a year – at Oktoberfest and Spring Conference.

3. On the phone board conference calls happen at least twice per year. Now there are Zoom conferences 6 times a year and usually on a weekday evening.

4. E-mails, including those requiring your vote, show up sporadically – usually before and after the main meetings. Please try to check for e-mail every day or two.

What is the term?

A board member term lasts two years. It starts at one Spring Conference Board meeting until ends at the Spring Conference Board meeting 2 years later.

Where's the fine print?

The organization's rules are the Bylaws as posted on the CBA website. Also, we have a Conflict of Interest policy that requires that you not participate in any decision that affects you personally. It is on the website too.

What should be in a Candidates statement?

Well, you've seen them in the CBA Magazine every January but here are my suggestions:

- -- A couple of paragraphs usually suffice.
- -- Introduce yourself; explain what blacksmithing and the CBA mean to you.
- -- Mention your role in CBA activities.
- -- Optionally, discuss what you want to work on to make the CBA better.

You are asking me to write this Candidate statement. What if I can't write?

Call me and I will help out with that.

Any hints for the photo?

The magazine needs a well-focused image with enough resolution (pixels) and contrast so it will print well. For a headshot, that usually means about a 1 MB or more file size. The purpose of the photo is to allow our members to put a name with a face.

What's the deadline?

The magazine cutoff is in mid-November so don't delay. Any questions, please call text or e-mail.
